I understand that I must pay the amount due within 14 days of the date I am notified. This payment must be in the form of cash, money order, or cashier's check. If the loan is not paid as herein agreed, any balance remaining unpaid will be considered to be in default and will be subject to an annual percentage rate of 12%. I understand KU Endowment will initiate legal action if I fail to satisfy this loan agreement. This loan may be turned over for collection by an outside agency. I understand I will be responsible for all costs and fees associated with any collection activity as permitted by Federal and State laws, and that the delinquency may be reported to a credit reporting agency.
